KC-192-22-B AMENDMENT TO AGREEMENT 2233

This Amendment ("Amendment") to Kitsap Public Health District Interlocal Agreement 2233 for Customized GIS Services ("Agreement"), is entered into between the Kitsap County, Department of Information Services (County/IS) and the Kitsap Public Health District ("District").

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Agreement, numbered as Kitsap County Agreement No. 192-22 and executed on April 13, 2021, and amended on November 2, 2022, shall be amended as follows:

1. Section 16 regarding Property will be added to the Agreement and read as follows:

<u>Property</u>. Any property acquired by a party under this Agreement shall be the sole and separate property of the acquiring party, which shall have the sole right of disposal of that property. Any property jointly acquired under this Agreement shall require a separate written agreement to address the acquisition, storage, maintenance, insurance, and disposition of the jointly acquired property.

2. Section 17 regarding Administration will be added to the Agreement and read as follows:

Administration. No separate legal or administrative entity is intended to be created pursuant to this Agreement nor do the parties intend to create through this Agreement a separate legal or administrative entity subject to suit. No obligation, except as stated herein, shall be created between the Parties or between the parties and any applicable bidder or contractor. Neither party is intending to assume responsibility or liability for the actions, or failures to act, of the other party and/or their respective employees. Each party shall have a representative to administer the Agreement. Either party may change its representative upon providing written notice to the other party.

Other Provisions Unchanged. Except as expressly provided in this Agreement Amendment, all other terms and conditions of the original Agreement, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.

<u>Authorization</u>. Each party signing below warrants to the other party that they have the full power and authority to execute this Amendment on behalf of the party for whom they sign.

<u>Counterparts/Electronic Signature</u>. The Agreement Amendment may be executed in several counterparts, each of which will be deemed an original, but all of which together will constitute one and the same agreement. A facsimile, email, or other electronically delivered signatures of the parties shall be deemed to constitute original signatures and deemed to constitute duplicate originals.
