Don't force more small businesses to close right at the busiest time of year. This will only cause more Washingtonians to move out of this state.


Do the right thing. Vote AGAINST vaccine passports!!

HOSPITALIZATION COUNTS


● Hospitalizations ● Incomplete — Hospitalizations (7 day avg.) — Incomplete (7 day avg.)

Dear Health Department Board,

25th October 2021

I hope you will use some common sense and decide that vaccine passports and mandating businesses to enforce these regulations is not the right choice for Kitsap County residents. Please rescind the motion that was presented October 4th, 2021 and take the do nothing approach.

We already have the areas surrounding us – Jefferson County requiring the vaccine passport to dine indoors. Certainly, if there are areas that residents want a sense of security by requiring these restrictions than by all means, but to make the entire County abide is grievous and unthinkable. I will make these points.

First, those that have not chosen to be vaccinated:

1. Have had Covid and recovered having natural immunity.
2. Are not scared of getting Covid as they have worked in environments that they were exposed daily before the vaccine approval. Again, having natural immunity. Our heroes a year ago Now zeroes because they won't comply and take the jab.
3. Maybe those that have not been vaccinated still consider the vaccine to be experimental. There is not enough information out to accurately assess if the jab is right for them. They choose to wait it out to see exactly what the death and injury toll is from the vaccine. There is little to no information nor data as to the side effects, death being one of them. Part of medical informed consent – I get the statistics about the risks, and I get to make an informed choice or decision that is right for me and my family.
4. Their doctor recommended No Vaccine for them due to anaphylactic shock and death. I have knowledge of at least 6 Covid vaccine deaths in Washington State, probably this is higher.
5. They are vaccinated, and deem this an invasion of privacy so refuse to show paperwork.

Second, the definition of fully vaccinated keeps changing. The data collection is also flawed, as the rules keep changing. Third, businesses shouldn't have to enforce (police) their customers, harassing them for paperwork and identification to enter the store or to enjoy a meal at the restaurant. Are we that close to being a socialist country? Fourth, Isn't having to show identification to shop discrimination? It is when it comes to voting. Fifth, Isn't this segregation? Sounds and looks like Jim Crow laws, which were crafted out of emotion - Not Science. Jim Crow laws were based on anger. The Covid laws are based on fear - Not Science. Sixth, the Covid vaccine does not decrease the transmission of the disease. In fact, it might have been the cause of the increased Covid cases seen in August 2020 in the United States.

Dear Mr. Grellner,

I am objecting to any further restrictions in Kitsap County for Covid. I realize you are getting a considerable amount of money, which is very tempting to follow those who dole the money out. This is NOT science. It is fear and tyranny. It is being bought and paid for. It is not serving the people but following the money. I am really tired of this and it is taking more of a toll on my health than Covid did. The anxiety of feeling like I am going to be yelled at in a store for not wearing a mask is troubling. Just the anxiety of going anywhere is ridiculous. I am almost 70 years old. I do not need someone telling me what to do. I cannot enjoy my retirement because of your stupid covid restrictions. Washington is one of the only states with the severe rules. You are so worried about "saving lives" yet you don't care about the anxiety and stress all this causes. All you care about is the money.

I am just sharing my experience. I am a covid survivor. I received monoclonal antibody therapy. I cannot get a vaccine for a minimum of 90 days. If you pass the mandate that forces us to get a shot or not be able to go to a store, restaurant, or other public places, I will be stuck at home and not be able to take care of myself. I am one example. This would seriously hinder my freedom of movement, my constitutional rights and my mental health.

My domestic partner was exposed to covid the same time as me, was around me during my sickness and never got it. He tested negative when tested and has not been vaccinated. His immune system doesn't need the vaccine. Why should he put something in his body that he doesn't need? What if it had the opposite outcome and he became sick? We just don't know what these vaccines do to everyone. One size fits all is political, not medicine.

I have another friend who was an avid hiker, healthy, self supporting, in college, and he got the shot because he was encouraged to do so by family members and so he could continue his education. He got Gillian Barr syndrome and that totally changed his life. Nobody is compensating him for this, he cannot get state help, his schooling has been postponed and it has devastated his life. What about him?

These shots are not one size fits all. To mandate forced compliance is political not healthcare. What about all the people who have survived this illness and now have natural immunity. Taking a vaccine could overload their systems. We just don't know that much about this. I didn't hear any talk about natural immunity. All I hear about is forced compliance. Please think outside the box and don't give in to political pressure.

Hello Mr. Grellner.

I am writing to express my opinion regarding the KPHB potentially mandating a covid vaccination passport in Kitsap County.

I believe that this is a poor strategy and will not achieve the desired outcome of fewer cases of Covid-19 in Kitsap County.

Recent research has shown that even vaccinated people can be infected by and transmit the coronavirus.

In addition, businesses in Kitsap will be harmed by this by having to police their customers (which is not their responsibility) and by losing customers because of unvaccinated people no longer patronizing their businesses.

At this time, anyone who was going to receive the vaccine has already done so, and those who do not want to receive the vaccine will probably not change their mind, even with a vaccine passport put in place. They will either reduce their financial expenditures or travel to other jurisdictions that do not have a passport to spend their money.

Other recent research also shows that people who are healthy either resist getting infected by the coronavirus because of their strong immune system or if they do get infected they have relatively mild cases that do not require hospitalization or end in death.

The public health message should be, GET HEALTHY. The CDC themselves have stated that 90% of chronic illness is lifestyle related and most is reversible.

The other public health message should be to seek early treatment. It has been shown that early treatment saves lives, and removes the burden from the hospital.

Please pass this message on to the Kitsap Public Health Board members.
