#### 2024 PERMITTED SOLID WASTE COMPANIES IN KITSAP COUNTY

Use this document to find a company permitted to provide solid waste services in Kitsap County, Washington. The hauling of solid waste is **regulated by the Washington Utilities and Transportation Commission (UTC)**, **Washington Department of Ecology (Ecology)**, **and Kitsap Public Health District (KPHD)**. Solid waste includes garbage and recyclable materials.

#### GARBAGE SERVICES- Order a garbage dumpster or container and fill it myself.

The following companies are authorized to provide garbage services to residential and commercial customers within their service areas:

Companies that provide a garbage dumpster, drop-box, cart, container, or truck/trailer to be filled by a customer must have authority from the UTC and an annual Solid Waste Hauling Permit from KPHD. Providing or advertising for garbage services without proper authority from the UTC may be subject to a penalty of up to \$1,000 per violation. Report illegal haulers to **reportillegalhauler@utc.wa.gov**. Garbage includes landfilled construction and demolition wastes.

### CLEAN UP SERVICES- Hire a company to clean up my residential or commercial property.

#### 2024 PERMITTED SOLID WASTE COMPANIES IN KITSAP COUNTY

Companies providing clean-up services may haul solid waste as an incidental part of the clean-up project. Company employees must load and haul the waste using company-owned equipment. Customers cannot load waste into company-owned equipment or set the waste at the curb for collection by the company. Companies must have an annual Site Restoration Permit from KPHD.

# <u>COMMERCIAL RECYCLING SERVICES: Order a dumpster or container for recyclables</u> <u>from my commercial property.</u>

The following companies are authorized to provide commercial recycling services in Kitsap County:

Companies that provide dumpsters, drop-boxes, carts, containers, or trucks/trailers to be filled with recyclable materials by the customer must have **UTC Common Carrier Authority**, an annual Solid Waste Hauling Permit from KPHD, and they must register with Ecology as a **Transporter of Recyclable Materials**.

# <u>BIOHAZARDOUS WASTE SERVICES:</u> <u>Order biohazardous or biomedical waste hauling</u> services.

The hauling of biohazardous or biomedical wastes is regulated by the **Washington Utilities and Transportation Commission (UTC) and Kitsap Public Health District (KPHD)**. Companies must have authority from the UTC and a Solid Waste Hauling Permit from KPHD.

The following companies are authorized to provide biohazardous waste services in Kitsap County:
