# **Professional Learning**

## Webinar: Rural Youth's Perspective on Why Teens Use Marijuana

The Healthy Youth Survey provides a lot of information about the health and behaviors of adolescents in Washington State but due to small sample sizes some data is suppressed which leaves many unanswered questions for professionals who serve the youth population. One of those population groups is youth who live in rural settings.

The YMPEP Strategic Planning Team identified rural youth as a priority population because historically these populations have higher substance use rates. The team needed to identify the specific disparities that exist among youth who live in rural areas but their knowledge and experience living and working within their communities, and the data they did have about their region provided a starting point for further discussion about the specific disparities among this population.

The Kitsap County YMPEP Team partnered with WSU Extension to hold Youth Community Conversations to learn from youth between 14-20 years old living in rural Kitsap County why teens do or don't use marijuana.

# **Current Marijuana Landscape**

# New Packaging and Labeling Requirements

Effective January 1, 2019 all marijuana products must contain the following: **Current Rules**: **New Rules:** 

- "This product contains marijuana"
- "This product may be unlawful outside of Washington state"
- "This product has intoxicating effects and may be habit forming"
- Concentration of THC (total THC and activated THC-A) and CBD (total CBD and activated CBD-A)
- Business/Trade Name and UBI of producer, processor, and retailer
- 16 digit inventory ID
- Net weight in ounces and grams or volume as appropriate
- Accompanying materials affixed or given separately to consumer

- "Warning May be habit forming"
- "Unlawful outside of Washington State"
- "It is illegal to operate a motor vehicle while under the influence of marijuana"
- Business/Trade Name and 9 digit UBI of producer and processor
- Unique identifier generated by traceability
- Electronic format, including URL/QR code, option for accompanying materials
- Universal Symbol





New rules will also go into effect for edibles, usable marijuana, concentrates, and topicals. Accompanying materia about pesticides will also be required.

Adjustments will be made to packages including packing infused liquid products with more than one serving in resealable package/containers and providing separate measuring devices for liquid edibles with multiple servings.

# Retail and Medical Marijuana Store Locations

Washington State currently has 497 marijuana retail stores with some of those being medically endorsed.

Marijuana medical and retail stores may not be within 1000 feet of any elementary or secondary school, playground, recreation center or facility, child care center, public park, public transit center, library, or game arcade that allows minors to enter.


